BOARD & COMMITTEE APPOINTMENTS

Community Preservation Committee (1 Full Seat) (1, 3-Year Term)

- **Joan Bartlett (Incumbent),** said that she has been a member of the CPC for 18 years. Ms. Bartlett said the overall goals of the CPC and what has been accomplished since the Town voted to join the CPA 20 years ago. Ms. Bartlett said that she is involved with writing and archiving CPC's activities and initiatives.

Mr. Bletzer thanked Ms. Bartlett for her service. Mr. Bletzer asked her what her biggest accomplishment is and what is her biggest failure on CPC. Ms. Bartlett said that her biggest accomplishment, although not yet complete, is the Spire Center, and the acreage of open space that has been conserved. Ms. Bartlett said that it is disappointing that Stephens Field is not yet complete.

- **Betty Cavacco**, said that she is a Town Meeting member and a former Select Board member. Ms. Cavacco said that she believes the CPC has become stagnant and needs a new vision to move forward. Ms. Cavacco thanked Ms. Bartlett for her 18 years of service on CPC. Ms. Cavacco said that she believes that CPC should have a better relationship with the

Town staff, including the Town Manager. Mr. Mahoney asked Ms. Cavacco if she would be comfortable to have the CPC meetings be viewed by the public. Ms. Cavacco said that Town staff and the public should have the ability to speak during all public meetings. Ms. Cavacco said that she believes that CPC violated procurement laws. Mr. Bletzer asked Ms. Cavacco what she would do better if she was appointed to the CPC. Ms. Cavacco said that communication is important to her.

Mr. Bletzer said that his voting for appointments is not politically driven. Mr. Bletzer said that he is voting for the best position.

Mr. Helm asked if Ms. Cavacco was in favor of the Town acquiring the Simes House, and then utilizing CPA funds. Ms. Cavacco said that she was not in favor of the Town acquiring the Simes House. Ms. Cavacco said the Simes House is a money pit. Ms. Cavacco said that the Town should sell the Simes House. Ms. Cavacco said that the Simes House should have been a commercial kitchen.

Mr. Canty said that the CPC over the years, has supported minimum affordable housing projects. Mr. Canty said that he believes the affordable housing that the Town develops is important for the overall economic vibrancy of the Town, he asked Ms. Cavacco what her priorities are regarding the development of affordable housing. Ms. Cavacco said that affordable housing is a priority for her.

Mr. Mahoney said that he was the Board representative to the CPC for 10 years, and then was again reappointed, after a two-year gap. Mr. Mahoney said he believed the CPC was different and was not allowing applicants to present their proposed applications to CPC. Mr. Mahoney said that he believes Town Department heads were not allowed to attend CPC meetings. Mr. Mahoney said that he is concerned with transparency in the CPC.

Mr. Canty thanked Ms. Bartlett for her 18 years of service. Mr. Canty said that as the former Chair of the Advisory & Finance Committee, he said that CPC was generally at or exceeding past deadlines. Mr. Canty said that it has been common for the CPC to submit placeholders after the warrant article submission deadline. Mr. Canty said that the CPC not submitting articles that adhere to the Town Meeting Warrant Article Submission Policy, is unprecedented. Mr. Canty said that he believes the CPC should be prioritizing affordable housing because the Town can decide where the developments would be located, and how they are designed, rather than 40b developments.

Mr. Main said that he believed he lost his temper during an ongoing lawsuit and apologized for his conduct. Mr. Canty asked Mr. Main how he would proceed with decorum during future Zoning Board of Appeals meetings. Mr. Main says that he believes decorum is important for himself and the ZBA.

- Thomas Wallace, 30 Highland Terrace, said that he is applying for the Alternate position on the ZBA. Mr. Wallace said that he has experience with zoning and zoning ordinances. Mr. Canty. Mr. Canty said that he suggests, that if Mr. Wallace is interested in an Alternate position, the Board consider the two full voting seats, and then determine if an Alternate Seat is open, if open, the Board could readvertise for the Alternate Seat to comply with Open Meeting Law.

PUBLIC COMMENTS

Richard Serkey, Precinct 2, said that he is disappointed that the Board did not allow for comments from the public before and during the Board & Committee appointments process. Mr. Serkey said that he disagreed with the procedure and the result of the CPC appointment.

Patricia Adelmann, Precinct 12, said that she believes that a Zoning Board of Appeals appointee incorrectly accused an applicant of lying. Ms. Adelmann said that she heard from a CPC applicant that the procurement law was violated by CPC. Ms. Adelmann said that she believes those accusations cannot be said, without evidence.

Nicole O'Brien, requestor of Administrative Note 3, said that the Board should not have approved the Rainbow Crosswalk request from Plymouth Pride Inc., she believes that the Board in a previous year, voted to allow for the request in perpetuity. Ms. O'Brien said that she would like to withdraw the request on behalf of Plymouth Pride Inc. Mr. Brindisi stated that if Ms. O'Brien withdraws her request, the crosswalk will not be repainted. Mr. Brindisi referenced Town Counsel's opinion that a Board, cannot bind a future Board. Mr. Brindisi said that the crosswalk is not painted, due to recent repaving and construction for the Water Street Sewer Interceptor Project. Ms. O'Brien, who was live via Zoom, interrupted Mr. Brindisi, about the nature of the request. Mr. Quintal, gaveled, to maintain order at the Board meeting. Mr. Canty stated that if the Board does not vote to reconsider the vote of Administrative Note 3, the original vote by the Board stands. Mr. Helm said that he believes the Board's original vote stands because it would cause an unfortunate delay to the painting of the crosswalk.

Betty Cavacco responded to Ms. Adelmann and said that she believes that CPC violated the procurement law, and paid \$17,000 to dismantle a home, on the Sevier property, without going through procurement to get three bids.

Ms. O'Brien, now participating in person, said that if the Board votes on the request for a rainbow crosswalk every year, that sets a precedent.

VETERANS' CONCERT UPDATE

Mr. Brindisi said that country music star Ricky Lee, will be performing at Memorial Hall on July 1, 2023, at 6:00 p.m. for a free concert.

FOURTH OF JULY PARADE & EVENTS UPDATE

Mr. Tavares provided an update regarding the Fourth of July Parade and Events in the Town of Plymouth.

VERIZON CABLE LICENSE AGREEMENT

Paul McGee, Chair of the Cable Advisory Committee, presented the Verizon Cable License Agreement 5-Year Renewal that was negotiated with Verizon. Mr. Mahoney asked what the future will be for revenue for the public access services in Plymouth. Mr. McGee stated that the subscriber rate for cable in Plymouth has decreased 5-7% every year, which is directly correlated to Cable Fees. Mr. McGee said that the Cable Advisory Committee will need to

strategize in the future on how to make sure programs like EDTV and PACTV are funded. Mr. McGee said that Verizon has the option to opt out of the agreement in three years.

Mr. Len Levin, a Cable Advisory Committee member, said that the Town should actively look into options to fund public access stations.

On a motion by Charlie Bletzer and seconded by Harry Helm, the Board voted to approve and execute the Verizon Cable License Agreement, as presented by the Cable Advisory Committee.

Mr. Canty read the Bond Anticipation Note documentation and description into the record.

Mr. Mahoney asked Ms. Barrett what the Bond Anticipation Notes consist of. Ms. Barrett says the Bond Anticipation Note is for 1 year, for 15-20 projects. Ms. Barrett stated that the net interest cost for the Bond is the lowest net interest cost of the five bids. Ms. Barrett said that based on interest rates in the future, the Town may not seek as many Bonds Anticipation Notes.

On a motion by Kevin Canty and seconded by Harry Helm, the Board voted to approve and execute the Bond Anticipation Note as presented.

TOWN MANAGER'S REPORT

Mr. Brindisi said that Mr. Bletzer, the Town staff, the State delegation, Former Senate President Murray, and the new MassDCR Commissioner, had a meeting to discuss the Town acquiring the State Pier and DCR State Park.

Mr. Brindisi said that the Police Department on July 7, 2023, will close permanently the access road behind the Shops at 5, and the County Sherriff's Department.

Mr. Brindisi gave a Water Street Interceptor Project Update. Mr. Brindisi said that Northern Construction Services is removing the sheathing this week. Mr. Brindisi said that next week, the road will be put completely back together. Mr. Brindisi said that DPW is working with Northern Construction Services to finalize the plan to resume work after Thanksgiving.

Mr. Brindisi said that Allerton Street Park Playground construction is complete, and the park is now open.

Mr. Brindisi said that the Transfer Station gates will be closed at 3:45 p.m. to allow residents to dispose of their trash promptly. Mr. Brindisi said that this will be effective July 1, 2023.

Mr. Brindisi said that Plymouth has a harm reduction center, and the Town Manager attended the opening of the center recently. Mr. Brindisi highlighted the need for the Town to partner with organizations through the newly formed Health and Human Services Department.

Mr. Brindisi said that the Town will be fully transitioning dispatch service to the Sheriff's Department effective June 30, 2023.

Mr. Helm said that the Town should hold a grand opening ceremony for Allerton Street Park.

SELECT BOARD OPEN DISCUSSION

Mr. Mahoney said that he attended a meeting in the Town of Hanover regarding potential dam removal projects in their region. Mr. Mahoney said that Plymouth is known as a leader in remediation and removal efforts.

Mr. Helm thanked Mr. Senesi for his efforts in creating and implementing the Select Board Online Volunteer Application Form.

ADJOURNMENT OF OPEN SESSION

On a motion by John Mahoney and seconded by Harry Helm, the Board voted to adjourn the Open Session at 9:14 p.m. and go into Executive Session, following Executive Session, the Board will not reconvene back to Open Session.
