- 1. The Board will vote to approve the amended Board and Committee Handbook as presented in the weekly packet.
- 2. The Board will vote to approve and execute the amended Long Beach 4 x 4 Parking Sticker Eligibility Policy as presented in the agenda packet, effective immediately.
- 3. The Board will vote to approve and execute the amended Resident Beach Sticker Eligibility Policy as presented in the agenda packet, effective immediately.
- 4. The Board will vote to approve and execute a Lease between the Town of Plymouth and Shack on the Wharf for the property located at 16-18 Town Wharf.
- 5. The Board will vote to approve an Intermunicipal Agreement between the Town of Plymouth and the Town of Barnstable.
- 6. The Board will vote to re-appoint Patrick Farah to the Agricultural Commission for a three-year term expiring on June 30, 2026.
- 7. The Board will vote to authorize the application for, and (if awarded) acceptance of, a grant in the amount of \$337,735 through the Massachusetts Office of Coastal Zone Management's (CZM) Coastal Resilience Program, for feasibility, design,

and permitting expenses associated with the Long Beach Salt Marsh Restoration Project.

- 8. The Board will vote to authorize the application for, and (if awarded acceptance of, a grant in the amount of \$500,000 through the Massachusetts Division of Conservation Service's (DCS) Parkland Acquisitions & Renovations for Communities (PARC) Program, for construction expenses associated with the Town Brook Park Trail Improvement Project.
- 9. The Board will vote to accept a grant in the amount of \$56,250 through the U.S. Fish & Wildlife Service's Clean Vessel Act Grant Program, for the purchase of a new pump-out boat which provides free pump-out service for recreational boats in Plymouth Harbor.
- 10. The Board will vote to transfer funds from the Human Resources expenses budget to the Human Resources Salary Budget in the amount of \$3,340.05.
- 11. The Board will vote to transfer funds from the Fire Salary budget to the Fire R & M Vehicles Budget in the amount of \$45,000.
- The Board will vote to waive its first right of refusal under Chapter 61, Section 9 for lot A-360 recorded with the Plymouth County Registry of Deeds as plan no. 203 of 2023 Book 67, Page 132.

SELECT BOARD OPEN DISCUSSION

Mr. Bletzer acknowledged Mr. Don Williams and the Herring Pond Watershed Donation for the Hedges Pond Half-Day Summer Camp Program.

TOWN MANAGER'S REPORT

Mr. Brindisi said that the NAO/Trinidad Tall Ship is docked at Plymouth Harbor currently, from July 11, 2023, to July 23, 2023 from 8:00 a.m. to 8:00 p.m. Mr. Brindisi said that the ship is not blocking any winches.

Mr. Brindisi said that the Stephens Field project is now at to bid, and it is anticipated that the Project will begin construction in later Summer 2023.

Mr. Brindisi said that the 911 Dispatch Center consolidation at the Plymouth County Sheriff's Office has gone well. Mr. Brindisi said that the transition period will only be 30 days, as opposed to the original plan of 60 days.

Mr. Brindisi said that the Fourth of July festivities went well, with only 11 arrests.

Mr. Brindisi said that he would request that the DPW Interim Director speak with the Board on July 25, 2023, regarding significant ongoing projects in the Town.

Mr. Brindisi said that effective July 1, 2023, the Town-owned electric vehicle charging stations cost a fee to be used. Mr. Brindisi said that previously, the charging stations were free. Mr. Brindisi said that users will pay for the cost of the electricity plus \$2.00 administrative fees which will be placed in an account for future maintenance and upgrades of the charging stations. Mr. Mahoney asked if there is a revolving account that will be set up for the administrative funds. Mr. Brothers said yes, and the formation of the account will be proposed at Fall 2023 Town Meeting.

Mr. Mahoney asked Mr. Brindisi to provide an update regarding the anticipated American Cruise Lines arrivals. Mr. Brindisi said that August 19, 2023, August 26, 2023, and September 2, 2023, are the three arrival dates. Mr. Brindisi said that the arrival will be at 5:00 p.m.

Mr. Brindisi said that the Finance Director will be presenting a Municipal Finance Workshop to the Board later in August.

Mr. Quintal thanked for the July 4 Plymouth Committee for their efforts. Mr. Quintal thanked Town staff for their efforts.
